

## SUBSCRIPTIONS

1. The choir operates for 39 weeks of the year in line with local school terms and holidays; Spring, Summer, and Autumn. A termly commitment is acknowledged by choir members for full choir membership and subscriptions will be collected in line with this.
2. The subscriptions for Major Tonic Choir 2020-21 will be collected by monthly standing order of £16.25 per month spread over 12 months, including in the Christmas, Easter and Summer breaks. This works out at £5 a session over the 39 weeks of term and covers choir sessions online and in person.
3. It is the responsibility of the choir member to ensure that this standing order is set up correctly in advance of attending rehearsals.
4. Choir members who do not pay subscriptions in advance will cease to be members.
5. Payments are to be made directly to the Aquawebb Ltd bank account, details on the Members' page.
6. Full subscriptions will continue to be payable by choir members until the end of a choir term, in the event of absence for any reason from rehearsals and concerts whether online or in person.
7. Non-active full choir members, in order to support the activities of the choir, will pay a subscription to become an Associate Member. This subscription will be payable at a monthly standing order rate of £5 on the first of every month to Aquawebb Ltd bank account, details on the Members' page. At the discretion of the Music Director, from 16th June 2021, non payment of this Associate Membership by non-active choir members will incur a re-joining and administration fee of £25 for accessing continued full membership of the choir.
7. Non-active Associate Membership gives access to Major Tonic special events (social and musical), newsletters, access to the Major Tonic social media groups, and access to the members area of the website.
8. New full choir members will pay a weekly fee of £5 for each session in the month of joining if joining later in the month and therefore missing sessions that have taken place. If they are to attend all sessions in the month of joining, the monthly fee of £16.25 will be payable. Absence from a session after registering interest in joining the choir will be counted as a paid session.
9. Refunds or carry-overs are not given for non-attendance by choir members in full payment of subscriptions. Should Major Tonic cancel scheduled rehearsals for any reason extra rehearsals will be provided in lieu.
10. Two members or more of a family will be given a 10% discount of full subscriptions.
11. Aquawebb Ltd reserves the right to close or revise the activities of Major Tonic choir with a month's notice with no liability financial or otherwise.
12. Choir members do not pay to perform in concerts, although it may be necessary to charge for extra performance costs, such as but not exclusively venue hire, transport, props, costumes, support musicians and acts, extra rehearsals for performances. Notification of this will be made at least 4 weeks before any planned event or concert. All performances and events are optional.
13. Uniforms and black folders for Major Tonic Choir Waterloo are required for performances to be purchased by members and are not part of the subscription payments.
14. The Patreon and Buy me a Coffee websites, both sponsorship sites, operate as an extra to subscriptions. Please donate extra to the choir or other projects run by Aquawebb Ltd on those sites if you wish. Patronage through those sites does not imply patrons have membership of any of the choirs unless they are paid up monthly subscribers of the choir.
